B. Brown gave an update on the annual OCAF which has been completed. The outstanding receivable amount of \$50,000 is still being monitored.

B. Brown gave an update on skill development for staff during the transition process. Staff is currently working on recertifications and maintenance items.

B. Brown gave an update on abatement and demolition of the Senior building. Phase 2 application will be submitted in May 2025.
